(QC class is for any Toller entered in the regular classes that has a qualifying score in field, obedience, retrieving, agility, etc copy of pass or title must be supplied with entry)

Dogs must be on the main register to be eligible for entry for all property classes and must be entered in the confirmation show.

Property classes must be entered prior to close of entries.

The Best in Show and Runner Up to Best in Show winners will be ineligible to participate in property classes, but will be eligible to compete in Best Brace class and QC class.
