Check in Time: Trial one (both days) 8 - 8.30 am, trial two (both days) 11 - 11.30 am. Rally walk through 10 minutes prior to starting time

Judging Time: Trial one 9 am, trial two 45 minutes after completion of judging of trial one but not before 12 noon

Catering: Available

Awards: Obedience - cash and rosette for first place. Ribbons to second and third. Qualifying cards and ribbons/title sashes. Highest score in trial - prize and sash. CCD not eligible for highest scoring obedience awards. Rally - cash and rosette to first place, ribbons to second and third. Qualifying cards and ribbons. Title rosette
