QUALIFICATIONS: A '**NOVICE STAKE**' is a stake confined to Gundogs that have not won any Stake other than four Novice Stakes or have gained Championship Points and/or been awarded an AARD title.

A '**RESTRICTED STAKE**' is a stake confined to Gundogs that have not won five Restricted Stakes, or have gained Championship Points and/or been awarded an AARD title.

An '**ALL AGE STAKE**' is a stake confined to Gundogs that have won a Novice Stake, placed 1st, 2nd or 3rd in a Restricted Stake

TRIAL VENUES: Properties used for Trials are private properties and **MUST NOT** be revisited after the trial. Entry for the Trial is subject to this condition.
