<b>Vet Inspection</b>	7.00 – 7.30 am. Start Time asap. Competitors will be advised where Vetting will take place. <b>All competing dogs</b> will be required to be presented for vetting both days.
<b>Venue</b>	Riverland area. Competitors will be notified of venue after close of entries. <b>No alcohol is to be brought to/consumed at this event.</b>
<b>Camping</b>	Pet Friendly Caravan Parks: Cobdogla (3km away, phone 08 8588 7164), Lake Bonney Caravan Park Barmera · (6 km away, phone 08 8588 2234), Kingston on Murray (10km away, phone 08 8583 0209).
<b>Draw and Dinner</b>	A draw will be conducted at the State Dinner on Thursday 20 <sup>th</sup> August at Riverland Vintage and Classic Car Club Hall, Shueard Rd, Cobdogla. Directions: Signs out the front (about half way between the school and the caravan park). State Dinner (BBQ, salad, dessert) to be <b>prepaid</b> by close of State Championship entries \$16.00 per person, via Easydog or cheque with entries. BYO alcohol, soft drinks for sale. Running order will be in the catalogue.
<b>Trophies</b>	Cash, Trophies and Rosettes will be presented for 1 <sup>st</sup> , 2 <sup>nd</sup> , 3 <sup>rd</sup> , 4 <sup>th</sup> and 5 <sup>th</sup> places. Specialist trophies will also be presented where donated. A full list will be printed in the catalogue.
<b>A Championship Retrieving Trial Stake</b>	Refer to ANKC rules for the conduct of Retrieving Trials for Gundogs, Rules 40 (a), 40 (b), and 49.
<b>Rules</b>	This trial will be conducted under the Rules for the Conduct of Retrieving Trials for Gundogs as approved by the Australian National Kennel Council and effective 1 <sup>st</sup> January 2020.
<b>Department of Environment, Water and Natural Resources</b>	It is a condition of our use of the Department of Environment, Water and Natural Resources property that all exhibitors clean up after their dogs and that dogs are on lead at all times except when competing.

<b>Firearms Licence</b>	<b>South Australian Firearms Regulations 2017—1.7.2017</b> <b>35—Duty to carry licence</b> (1) A licensee must carry the licensee's firearms licence, or a legible copy of the licensee's firearms licence (which may be in electronic form), when the licensee has physical possession or control of a firearm under the licence or is supervising the use of a firearm by another person in circumstances authorised under the Act. Maximum penalty: \$5 000.
<b>Hot Weather Policy</b>	<b>applies, if forecast temperature at 10.00 am two days prior on <a href="http://eldersweather.com.au">eldersweather.com.au</a> is 32° or above the trial will be cancelled, unless there is ample swimming water on the property.</b> Where an Exhibition is cancelled in accordance with the Hot Weather Rules, no entry fees will be refunded. Effective 1 <sup>st</sup> January 2019. Contact convenor if in doubt.

## CONDITIONS OF ENTRY

**There is no training on designated trial grounds within 28 days before a Trial.**  
Dogs SA Rules - *PART VIII EXHIBITIONS*, C, Rule 15 Competitors, b.

The only **exercise area** is stipulated by the Trial Manager, or his delegate (the Run Manager). Exhibitors will know where the exercise area is and therefore they are able to warm up their dogs with dummies etc if they wish. Any other area is deemed trial grounds and so no training allowed.

Bitches in Oestrus will not be permitted to compete. They may be on the property but not in the vicinity of the Trial Site or area of the runs.

ALL DOGS on the trial site **must be on a lead at all times** (except when competing), the lead must be held in the hand or the dog tethered.

All non-competing dogs must be vetted and left in the designated area. No dogs in the gallery.
